
### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 449

1. Public comments.
2. Approve minutes.
3. Authorize auditor to conduct audit for fiscal year end March 31, 2023.
4. Approve Developer Reimbursement Report and authorize disbursement of bond proceeds.
5. Financial and bookkeeping matters, including adoption or amendment of budget, approval of Depository Pledge Agreements, payment of bills, and opening of bank accounts, if appropriate.
6. Adopt budget for fiscal year end March 31, 2024.

11. Security report, including proposals from Today's Integration for additional security camera installation(s) at certain intersections and District facilities.
