

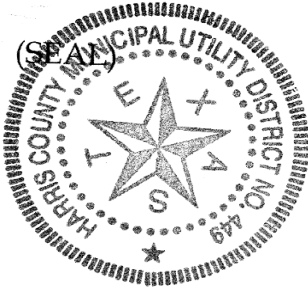
NOTICE OF MEETING


HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 449

The Board of Directors of Harris County Municipal Utility District No. 449 will hold a regular meeting on **Thursday, April 10, 2025, at 8:00 a.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **Suite 2400, San Jacinto Conference Room**, Houston, Texas 77027, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Financial and bookkeeping matters, including adoption or amendment of budget, approval of Depository Pledge Agreements, payment of bills, and opening of bank accounts, if appropriate.
4. Tax Assessor/Collector report, including payment of the bills on the tax account, approval of Depository Pledge Agreements, and requests for estimates of taxable value.
5. Operation of District facilities, including:
 - a. billings, repairs and maintenance;
 - b. amend Rate Order, if appropriate;
 - c. conduct annual review of the Identity Theft Program and take appropriate action; and
 - d. garbage collection matters and take appropriate action.
6. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
7. Maintenance of detention ponds and District facility sites, including proposals for additional work.
8. Security report, including authorize installation of additional cameras, if appropriate.
9. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. service request from Harris County Emergency Services District No. 48;
 - b. approve easements and agreements;
 - c. approve plans and specifications and authorize advertisement for bids for construction of additional projects; and
 - d. elevated storage tank waiver.

10. Parks and recreational facilities matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. Ventana East Detention Trails;
 - b. Ventana Lakes East Dog Park;
 - c. Ventana Lakes East Drill Site;
 - d. Ventana Lakes East Park;
 - e. Porter Ranch Detention Pond Amenity project; and
 - f. lighting of park land.
11. Development matters.
12. Communication and website matters, including consideration of proposals and authorize appropriate action.
13. Meeting schedule and items for inclusion on the next agenda.
